SUMMARY

Assembly District 2 is the 19th most racially disparate Assembly district in California. It ranks 41st out of 80 Assembly districts in outcomes such as employment, health insurance, and homeownership.

BACKGROUND

RACE COUNTS analyzed 31 indicators, across seven issue areas, for every State Assembly District and ranked districts by their outcomes and differences in those outcomes among racial groups.

Data sources for indicators include the California Department of Education, the California Department of Justice, the California Office of Environmental Health Hazard Assessment, the U.S. Census Bureau's American Community Survey, and others. WHY THIS IS IMPORTANT

Understanding racial disparities in each district is essential to creating fair and effective policy. Data on racial disparities highlight where local systems fail to deliver equitable outcomes and reveal opportunities for targeted policies that close gaps. By examining these disparities, policymakers can work alongside their constituents to promote equity in their districts.

Across indicators in Assembly District 2, American Indian / Alaska Native residents are most impacted by racial disparity, with the worst rates for 11 out of 26 indicators with available data. All races lose when systemic racism remains unchecked.
