## Assembly District 32 Profile

### SUMMARY

Assembly District 32 is the 22nd most racially disparate Assembly district in California. It ranks 50th out of 80 Assembly districts in outcomes such as employment, health insurance, and homeownership.

### BACKGROUND

RACE COUNTS analyzed 31 indicators, across seven issue areas, for every State Assembly District and ranked districts by their outcomes and differences in those outcomes among racial groups.

Data sources for indicators include the California Department of Education, the California Department of Justice, the California Office of Environmental Health Hazard Assessment, the U.S. Census Bureau's American Community Survey, and others. ### WHY THIS IS IMPORTANT

Understanding racial disparities in each district is essential to creating fair and effective policy. Data on racial disparities highlight where local systems fail to deliver equitable outcomes and reveal opportunities for targeted policies that close gaps. By examining these disparities, policymakers can work alongside their constituents to promote equity in their districts.

#### District 32 indicators with the worst outcomes:

#### District 32 indicators with the worst racial disparity:

- Officer-Initiated Stops
- Chronic Absenteeism
- School Suspensions
- Overcrowded Housing
- Subprime Mortgage Loans

Across indicators in Assembly District 32, Black residents are most impacted by racial disparity, with the worst rates for 8 out of 26 indicators with available data. All races lose when systemic racism remains unchecked.
