SUMMARY

Senate District 4 is the 20th most racially disparate Senate district in California. It ranks 22nd out of 40 Senate districts in outcomes such as employment, health insurance, and homeownership.

BACKGROUND

RACE COUNTS analyzed 31 indicators, across seven issue areas, for every State Senate District and ranked districts by their outcomes and differences in those outcomes among racial groups.

Data sources for indicators include the California Department of Education, the California Department of Justice, the California Office of Environmental Health Hazard Assessment, the U.S. Census Bureau's American Community Survey, and others. WHY THIS IS IMPORTANT

Understanding racial disparities in each district is essential to creating fair and effective policy. Data on racial disparities highlight where local systems fail to deliver equitable outcomes and reveal opportunities for targeted policies that close gaps. By examining these disparities, policymakers can work alongside their constituents to promote equity in their districts.

District 4 indicators with the worst racial disparity:

- School Suspensions

Across indicators in Senate District 4, Latinx residents are most impacted by racial disparity, with the worst rates for 10 out of 31 indicators with available data. All races lose when systemic racism remains unchecked.
